The University of Cambridge has a Hybrid Working Policy that aims to enable as many staff as possible to work in a hybrid way if they so wish, whilst recognising that some roles will include tasks that can only be performed on University premises.



Purpose of the role

To provide nursing to an excellent standard for the Queen's Veterinary School referral Hospital, to meet the needs of the service in the Small Animal Wing.

The referral hospital is a very fast-paced environment working with complex and seriously ill animals.

The small animal wing consists of four dog, two cat, critical care and isolation wards housing an average of 15-25 patients during the overnight period.

We are looking for nurses who can cover 24/7 working on a 7 week rotating basis, including weekend and night working. High degrees of flexibility and adaptability are required to meet the nursing requirements after the core nursing team have left for the day. 2 of the 7 week rota will be working core hours with a team of 8 nursing staff. All shifts have veterinary care assistant support.

The role in Small Animal inpatients will include surgical, medical and critical care nursing (training can be given in critical care procedures if needed). Cleaning, hygiene and administration duties linked to inpatient care will form a reasonable percentage of the working shift. All shifts will cover inpatient ward area only.

The previous nurse shift will hand over to you for the evening/night and night/early shifts, OOH's shift nurses will work with on-call interns and senior clinical students to ensure nursing procedures, treatments and maintenance of patient care is continued seamlessly out of core working hours. You may be the sole nurse covering the evening period, with a clinical team comprising of duty intern, residents, final year students and veterinary care assistants.

You will liaise with clients, clinicians, students and visitors by telephone or in person regarding all aspects of nursing of the patients.

The role will also require the management of Class A (schedule 2 and 3) drugs and you will be required to maintain all associated records when using these groups of medications.

Key responsibilities

Welfare and nursing of patients in the Small Animal Wing.

- Responsibility for management of at least one ward (when on core hours) includes cleaning, feeding, exercise regimes, pre/post-operative care, wound management, observation of dressings, drug administration, individual management protocols, fluid therapy management, bathing, physiotherapy and animal welfare, with veterinary care assistant support for husbandry tasks.
- Individual responsibility for patient care but also as part of a larger team.
- All duties are with a working knowledge and understanding of COSHH and Health and Safety at Work regulations.
- Observation and detection of indications of zoonotic and or infectious diseases.

Supervision and teaching of ;-

- Junior veterinary nurses nursing skills, work protocols etc.
- Veterinary Care assistant safety, advice, liaison on basic tasks.
- Students nursing skills: blood sampling, catheter placement, bandaging, enteral feeding, drug administration, general ward and animal hygiene, basic animal handling and care, administrative issues.
- Clients and visitors to guide around the facility to ensure they are safe and are no danger to themselves or others.

Assistance to Clinicians and preparation for a variety of procedures

- chest drainage
- bone marrow aspirates
- casting of limbs
- dressing changes and or wound management
- biopsy of tissue
- skin testing

Administration

- To ensure correct records are kept when dealing with Class A (schedule 2 and 3) drugs.
- Maintenance of accurate patient records.
- Maintain information systems that are linked with the production of invoices (costing of drugs, board and consumables).
- Ensure high levels of communication with senior nurses, other nursing staff, clinicians and students regarding individual patients (verbal and written).
- Use of a variety of written and computer-based systems.

Advanced Nursing procedures

- Assistance and participation in;-
 - Collection of blood for blood transfusion,
 - Setting up and monitoring of blood transfusions
 - Critical care monitoring arterial blood pressure, ECG, airway supervision etc
 - Blood typing
 - Care and management of the seizure patient

- Local ward pharmacy drug stocks maintained.
- Small ward inpatient use sterile packs stock maintained, cleaned and repacked.
- Sedatives drugs stock maintained

Isolation Unit

Mission statement

The Department of Veterinary Medicine is the Veterinary School of the University of Cambridge, the highest-rated research university in the United Kingdom, and one of the top five research universities in the world. The Department is part of the School of Biological Sciences (SBS), together with 8 other departments and 6 research institutes.

The Department provides an academic environment of the highest quality, within which world-class research and clinical teaching are performed. The fact that it is a constituent Department of the University of Cambridge enables excellent opportunities for collaboration with other world-class Departments and institutions within the University, amongst them the Clinical School at Addenbrooke's Hospital, the CRUK Cambridge Research Institute, and Departments of Pathology, the Zoology, Biochemistry, Genetics, Pharmacology, and Physiology, Development & Neuroscience, as well as with non-University institutions located in the Cambridge area, such as the Wellcome Trust Sanger Institute, the MRC Laboratory of Molecular Biology, the MRC Biostatistics Unit and the BBSRC Babraham Institute.

Our research encompasses basic and applied biomedical and veterinary/ clinical sciences ranging from the molecular to the population level and is configured into 3 research themes (Infection & Immunity, Disease Dynamics and Systems Pathology).

We have approximately 290 employees and 40 training scholars. The Department has approximately 65 veterinary clinical students and 40 PhD students per year. We aim to be internationally competitive in research, to foster collaborations with academia and industry, and to ensure that its undergraduate and postgraduate teaching and clinical work benefits from research excellence.

We put particular emphasis on research collaboration between the basic sciences and clinical research. This is promoted through a series of weekly seminar presentations attended by all research staff and clinicians in the Department, and by annual Departmental research days. We have a strong and varied seminar series which hosts many academic visitors from all over the world in many different disciplines.



School of Biological Sciences

. The School of the Biological Sciences is one of the six Schools that are responsible for delivering teaching and research and the administration of those activities within the University. The School delivers internationally-leading research and teaching on animal, plant and microbial science at scales that range from the atomic, molecular and cellular through whole organisms to populations and communities. The research pharmaceutical impacts on the and biotechnological industries, on human and animal health and the clinic as well as in conservation, agriculture and the environment.

About the School

The School of the Biological Sciences employs around 2000 staff teaching over 4000 students (around 2000 undergraduates in the Natural Sciences, Medical Sciences and Veterinary Sciences and Psychological and Behavioural Sciences Triposes plus around 2000 postgraduates).

The School collaborates closely with the School of Clinical Medicine. The joint Graduate School of Life Sciences looks strategically at graduate provision and education across the two Schools and at the

undergraduate level the Medical Education Committee oversees medical education.

The School is currently arranged in two Faculty Boards (Biology and Veterinary Medicine) which are divided into nine Departments: Biochemistry, Genetics, Pathology, Pharmacology, Physiology, Development and Neuroscience, Plant Sciences, Psychology and Zoology are part of the Faculty Board of Biology while Veterinary Medicine is part of the Faculty Board of Veterinary Medicine. The School also contains five major interdisciplinary Institutes: Wellcome Trust / CRUK Gurdon Institute for Cancer and Development, Wellcome Trust / MRC Stem Cell Institute, Cambridge Systems Biology Centre, Cambridge Centre for Crop Science and the Sainsbury Laboratory for Plant Development. It has also incorporated the MRC Toxicology Unit, Leicester which will physically relocate to Cambridge in 2020.

The School is involved with several Strategic Research Initiatives including being a major player in the Cambridge Conservation Initiative. The School is associated with the Museum of Zoology and the Botanic Garden.
